**NOTICE TO THE CREDITORS TO SUBMIT OUTSTANDING CLAIMS BY 30 JUNE 2022**

1. As you are aware, the Company has been subject to business rescue proceedings in terms of Chapter 6 of the Companies Act 71 of 2008 (“the **Act**”) since 2 March 2022 and was, as such, placed under the supervision of the undersigned business rescue practitioner (“**BRP**”).
2. Capitalized terms used, but not defined in this notice, shall bear the meaning as defined in the Company’s Business Rescue Plan, adopted on 7 June 2022 (“the **Plan**”).
3. All Creditors who are not reflected in Annexure B to the Plan, and who have not yet lodged their Claims against the Company, are required to lodge such Claims (with supporting documentation for each such claim) by no later than **30 June 2022**.
4. If you fail to file a Claim, your claim will be expunged and you may be forever barred from enforcing your claim against the Company.

5. In this regard, such Claims may be either accepted or rejected by the BRP. All Creditors are referred to the Dispute Resolution Mechanism set out in paragraph 10 of the Plan.
6. If, once such Claims have been accepted either by the BRP or as a consequence of the Dispute Resolution Mechanism, the BRP will be required to amend Annexure B to the Plan in accordance with paragraph 12 of the Plan, "Ability to Amend the Business Rescue Plan".
7. In the circumstances, if there are Creditors who believe they have a Claim against the Company, but have not yet submitted their Claim, then they are requested to download the Claim Form at <https://www.cbitele.com/business-rescue>, complete and e-mail the Claim Form (with supporting documentation) to [creditorsclaims@cbitele.com](mailto:creditorsclaims@cbitele.com).
